> ABOUT LLM CLASS



> CURRICULUM

This LLM Class is a coursework-based master's degree with thesis or journal publication. The program consists of five modules: general, thematic area of laws, elective, international exposure, and thesis, amounting to 40 credits in total. The program employs the interdisciplinary approach to achieve learning outcomes in various areas:

- **Environmental Law**
- **☑** International Law
- **☑** Business Law
- **☑** Law and Governance
- Criminal Law.

Furthermore, the program also provides opportunity for students to tailor their module based on the offered courses to accommodate their needs and interests.

The class will run for three semesters.

The program adopts blended learning system which is comprised of 40% of class meetings and 60% online learning. The class meetings will be organized for selected courses in two-three weeks intensive session in Faculty of Law.





THE DOMESTIC AND INTERNATIONAL STUDENTS:

The program accepts domestic and international students. For international students, we offer certain subjects to be taken independently as well as a complete postgraduate program.

THE COURSES:

- The general courses consist of several subjects which provide advance knowledge on Legal Theory, Law and Politic, Methodology of Legal Research and Legal Writings, Human Rights Law, amounting of total 13 credits.
- 2. **The thematic area** worth 10 credits which is based on concentration chosen by student at the start of the program.
- 3. **Elective course:** selected courses which students can choose from other concentration with total 6 credits
- 4. International Exposure (3 credits)
- 5. Master thesis/journal publication (8 credits)

ABOUT INTERNATIONAL EXPOSURE

For other international exposure programs, the Faculty has cooperation with many overseas universities around the world;

- Exchange program/international workshop;
- Paper presentation or attendance in an international conference;
- Publication in an indexed international publication;
- Participation in a summer course;
- Participation in a guest lecture;
- Internship;
- Research stay;
- Participation in an international elective course;
- Participation in an international competition; and

- ADVANTAGES
 - Opportunity to enroll into an exchange program in partner Universities such as Leiden University, Toulouse 1 University Capitole, and other excellent universities abroad.
 - 2. Graduates are awarded "Master of Laws" degree;
 - 3. Visiting professor from partner universities;
 - 4. Most lecturers graduated from prominent universities abroad.



DOUBLE DEGREE

One of the most significant advantages of being a student at master of Laws FH UGM is the availability of a double degree opportunity. This means the exceptional students have the chance to obtain two graduate degrees in law, one from UGM and one from a partner university abroad, without having to spend extra years. In approximately two years successful candidates will have obtained double LLM degrees from UGM and a partner university.

ADMISSION REQUIREMENTS

In order to be considered for admission into the program leading to the degree of Master of Laws (in the general stream with a thematic cluster), a candidate must:

- ► Hold a Bachelor of Laws (S.H./LL.B) degree or a Bachelor of Islamic Law/Sharia (S.H.I.) degree from a university or law school in Indonesia or abroad; Other degree with legal field experience is considered as well
- ► Have a minimum Grade Point Average (GPA) of 3.00 from a Faculty of Law with accreditation of "A"; or minimum 3.25 from a Faculty of Law with accreditation of "B";
- ► Fulfill an English language proficiency standard, demonstrated by a TOEFL score of at least 525; or an IELTS score of 6.0 on average;
- Submit a mini legal paper in English for approximately 1500 words;
- Pass an Academic Potential Test with minimum score of 500 (OTO BAPPENAS)/PAPS
- Pass a written and interview test.

> TUITION FEE

The tuition fee shall be paid every semester before the commencement of the lectures which will be reviewed every year

SCHOLARSHIP

Scholarship up to 50% of tuition fee is available only after passing certain criteria:
