▷ ABOUT LLM CLASS

Study Program of Master in Law (LL.M class) offered by the Faculty of Law, Universitas Gadjah Mada is one of the top postgraduate programs in Indonesia and Asia. The program is designed to produce high quality of alumni and enhancing opportunities to compete in global workplace environment particularly in the area of legal development. It offers unique modules that reflects the urgency to sharpening knowledge and skill responding to the current legal issues in Indonesia, South East Asia, and global context.



▷ CURRICULUM

This LLM Class is a coursework-based master's degree with thesis or journal publication. The program consists of five modules: general, thematic area of laws, elective, international exposure, and thesis, amounting to 56 credits in total. The program employs the interdisciplinary approach to achieve learning outcomes in various areas:

- ✔ **Environmental Law**
- ✔ **International Law**
- ✔ **Business Law**
- ✔ **Law and Governance**
- ✔ **Criminal Law.**

Furthermore, the program also provides opportunity for students to tailor their module based on the offered courses to accommodate their needs and interests.

The class will run for three semesters.

The program adopts blended learning system which is comprised of 40% of class meetings and 60% online learning. The class meetings will be organized for selected courses in two-three weeks intensive session in Faculty of Law.

ADMISSION REQUIREMENTS

To be considered for admission into the program leading to the degree of Master of Laws, a candidate shall:

- ▶ Hold a Bachelor of Laws (LL.B) degree from a university; Other degree with legal field experience is considered as well
- ▶ Have a Have excellent Academic records
- ▶ Fulfil an English language proficiency standard, demonstrated by a TOEFL ITP score of at least 525 or an IELTS score of 6.0 on average;

▷ TUITION FEE

The tuition fee shall be paid every semester before the commencement of the lectures which will be reviewed every year

▷ SCHOLARSHIP

▶ **Scholarship From Faculty**

International students who have strong recommendations from their universities or government institutions have the opportunity to get a full or partial scholarship for the tuition fee from the faculty. Please contact the study program for more information.

▶ **KNB Scholarship**

Kemitraan Negara Berkembang (Partnership for Developing Countries) Scholarship, popularly known as KNB Scholarship, is financial assistance offered by the Indonesian Government to prospective international students coming from developing countries to pursue their degree (Bachelor, Master or Doctorate Degree) at one of the universities in Indonesia including Faculty of Law Universitas Gadjah Mada.

► Requirement for master's degree KNB Scholarship

1. The maximum age to apply is 35 years old
2. Hold a bachelor's degree in law (please provide the scanned degree certificate and academic transcript in English or Bahasa. Please be advised that a master's degree holder is not eligible to apply for the master's degree scholarship.
3. Have the English Proficiency Test Score minimum: TOEFL ITP of 500, TOEFL IBT of 1, IELTS of 6.0, TOEIC of 575 or equivalent (the certificate must be obtained within the last two years). Participants from English-speaking countries or universities who are enrolled in programs in English (stated in the participant diploma/transcript), are not required to submit the English Proficiency document by attaching official proof from their home university.
4. Provide the recommendation letter to apply for a KNB scholarship from the Indonesian Embassy or Consulate General.
5. Provide a recommendation letter to apply for the KNB scholarship from the employer/immediate supervisor in English or Bahasa (if working).
6. Provide academic recommendation letter from previous schools in English or Bahasa
7. Provide academic certificate and academic transcript of bachelor's degree in law in English or Bahasa
8. Complete the online application form in <https://knb.kemdikbud.go.id/>

Please be advised that document (b), (e), (f), and (g) must be in English or Bahasa

▷ HOW TO APPLY

▶ **International candidates (Non-Indonesian candidates) shall follow the following instruction**

1. Candidate shall apply for the program through admission. ugm.ac.id/registration/
2. Candidate prepare for the following document
 - Photograph
 - LLB certificate/Diploma
 - Academic transcript
 - English Proficiency certificate (for non- English speaking countries)
 - Motivation Letter
 - Curriculum Vitae
 - Recommendation Letter
3. After receiving your application documents, the Office of International Affairs (OIA) member and the Faculty member will process it into an interview selection process. Applicants will be assessed against the following criteria:
 - Academic competence;
 - Potential outcome, including contribution to development outcomes in your home country;
 - Professional and personal leadership attributes
4. If you are selected as one of UGM 's student candidates, you will receive an email with a Letter of Offer (LO) requesting you to settle a non-refundable payment for tuition fees and any other fees.
5. Once the bank confirms the payment process, OIA will process the documents for a Letter of Acceptance (LoA).

6. You will receive the LoA and other information related to the courses offered, academic regulation, student buddy, etc. by email from admission@ugm.ac.id.
7. The Office of International Affairs at UGM will process the application documents for a study permit to the Directorate of Higher Education of Indonesia. The permit is usually issued in two months.
8. When the study permit is available, OIA will assist you in arranging for approval from the Immigration Office in Jakarta for the Limited Stay Visa (VITAS/Visa Tinggal Terbatas). Arranging both the study permit and VITAS approval will take at least three to four months.
9. Then, you will receive your VITAS (Limited Stay Visa/Visa Tinggal Terbatas) in your email directly from OIA (itas.oia@ugm.ac.id).
10. Students with a stay duration of more than four months must process VITAS (Student Visa).
11. You need to contact OIA no more than one week after you arrive in Indonesia via email admission@ugm.ac.id and cc: itas.oia@ugm.ac.id. Furthermore, you will receive other directions from OIA for completing your stay permit documents for your safety and convenience purpose.
